## PARTICIPATION IN PRO-RATA NON-RENOUNCEABLE RIGHTS ISSUE

## Overview

Washington Resources Limited ("Washington" or "the Company") wishes to announce a new fully underwritten non-renounceable pro-rata entitlements Options issue.

Washington invites Shareholders who are registered at 5.00pm WST on Tuesday, 6 October 2009 ("Registered Shareholders" at the "Record Date") to participate in a fully underwritten pro-rata non-renounceable rights issue of Options on the basis of nine (9) Options in the Company ("Options") for every ten (10) Shares already held, at an issue price of 0.1 cents per Option ("Rights Issue"). The Exercise Price of the Options is 40 cents per share with an expiry date of 31 December 2013. The closing price of Shares on the ASX on 22 September 2009 was 13.5 cents.

The Rights Issue will result in the issue of approximately 49,429,229 new Options ("Rights Issue Options") and if fully subscribed will raise approximately \$49,429 before costs of the offer.

A Prospectus has been prepared which has been lodged with the ASIC and the ASX on 21 September 2009 outlining the effect of the Rights Issue which will be mailed to Registered Shareholders together with the Entitlement and Acceptance Form on 12 October 2009. The Rights Issue is fully underwritten by Sonray Corporate Pty Ltd. Proceeds from the Rights Issue will be applied to:

- I. Increase general working capital; and
- II. Fund the costs of the offer.
