NOTICE OF PRO-RATA NON RENOUNCEABLE RIGHTS ISSUE OF OPTIONS**

Washington Resources Limited ("WRL" or "the Company") is pleased to announce a non-renounceable rights issue of options to raise approximately \$49,429.23 before costs ("Rights Issue").

The Rights Issue offers, to eligible shareholders, nine (9) Options in the Company for every ten (10) Shares held on the Record Date, at an issue price of 0.1 cents per Option. The exercise price is 40 cents per Share with an expiry date of 31 December 2013. The funds raised will be applied to general working capital.

As announced on 17 September 2009, the Company has entered into a conditional agreement to acquire all of the fully paid capital of Ferrum Crescent Limited, a company that has a 74% interest in the advanced Turquoise Moon Magnetite Pig Iron Project, which consists of the De Loskop Deposit and the Moonlight Deposit, located in the Limpopo region of South Africa. A JORC Compliant Inferred Resource of 320Mt grading at 32% Fe currently exists at the Moonlight Deposit, please refer to the announcement for more details.

The Rights Issue is fully underwritten with Sonray Corporate Pty Ltd.

A Prospectus will be issued for the Rights Issue which will be dispatched to shareholders including an Entitlement and Acceptance Form which will entitle eligible shareholders to take up their respective entitlements on 12 October 2009.
