Further to the announcement on 3 October 2013, the Company has today issued a total of 44,613,156 fully paid ordinary shares as the first tranche of a private placement totalling 48,000,000 ordinary shares at a price of GBP 0.0182 (AU\$0.0315) per share to raise up to GBP 873,000 (AU\$1.5 million) before the costs of the issue.

Additionally, further to the announcement on 6 September 2013 in respect of the Appendix 3B, the Company wishes to advise that it has 2,550,000 unquoted options on issue and not 2,850,000 as previously announced. The discrepancy of 300,000 options is due to a typographical error. An amended Appendix 3B is attached to this announcement to reflect the current position.
